BASICS IN SAFEGUARDING CHILDREN
(3 hour online learning/face to face)
 This is induction level training

NEGLECT AWARENESS WORKSHOP
(2 hour workshop)
 This is an induction level workshop to raise awareness of neglect and resources available (see Neglect Training Pathway for all neglect training)

NEL SCP LEVEL 1 TRAINING

INTRODUCTION TO SAFEGUARDING CHILDREN – LEVEL 1 (equivalent to Intercollegiate Level 3 Training, part 1) **CORE TRAINING**

Practitioners who have regular contact with children and young people and with adults who are parents or carers should attend this course.

You should attend this course prior to attending any other level 1 training courses.* This course is a pre-requisite to accessing any level 2 courses.

*** Exceptions are those going into homes for target hardening purposes who instead must complete 'Safeguarding Everyone' online learning before attending Domestic Abuse Awareness training**

HARMFUL SEXUALISED BEHAVIOUR WORKSHOP
 (stand-alone workshop)

PARENTAL MENTAL HEALTH E-LEARN or MENTAL HEALTH FIRST AID LITE
 (pre-requisite to Level 2 Parental Mental Health Training)

UNDERSTANDING SUBSTANCE USE Level 1
 (pre-requisite to attending Level 2 Substance Use if no knowledge of substances and their effects)

DOMESTIC ABUSE AWARENESS - Level 1 (pre-requisite to attending Level 2 Domestic Abuse training)

SAFER RECRUITMENT
 (stand-alone workshop)

LEVEL 1 SAFEGAURDING CHILDREN REFRESHER TRAINING
 (for those staff who do not require training at level 2. Should be undertaken 3 years after completion of the full level 1 training)

LEVEL 2 TRAINING

SAFEGUARDING CHILDREN Level 2*
 *(equivalent to part 2 of Intercollegiate Level 3 Training)
CORE TRAINING

PARENTAL MENTAL HEALTH AND THE IMPACT ON THE CHILD - Level 2

SUBSTANCE USE & THE IMPACT ON THE CHILD Level 2

DOMESTIC ABUSE AND THE IMPACT ON THE CHILD Level 2

KEEPING THE NEGLECTED CHILD IN FOCUS – Level 2
 (no level 1 course) (see separate training pathway for neglect)

SAFEGUARDING DISABLED CHILDREN Level 2
 (pre-requisite is Working with Children with Disabilities e-learning)

CRIMINAL AND SEXUAL EXPLOITATION OF CHILDREN Level 2
 (no level 1 course)

LEVEL 2 REFRESHER TRAINING
 Should be undertaken 3 years after completion of the full Level 2 'Safeguarding Children' training
CORE TRAINING

NEL SCP BRIEFING SESSIONS
 Subject specific briefing sessions held by the NEL SCP for practitioners on topical issues.

LEVEL 3 TRAINING

These courses are for specialist practitioners and will build upon level 2 inter-agency training, with more focus on theoretical input. (See Neglect Training Pathway for details)
